COVID 19 SKIER ASSURANCE STATEMENT: In the event that NY State mandates closure of McCauley Mountain after opening day, the following conditions will apply:

If closure occurs within 40 days of opening, 50% of the cost paid will be applied to the purchase of a 2021-22 season pass. If closure occurs from 41-60 days of opening, 30% of the cost paid will be applied to the purchase of a 2021-22 season pass. After 61 days from the opening date, no adjustments will be available.

Downhill skiing & snowboarding, like many other sports, contains inherent risks including, but not limited to the risk of personal injury, including catastrophic injury, or death, or property damage, which may be caused by variations in terrain or weather conditions, surface or subsurface snow, ice, bare spots, or areas of thin cover, moguls, ruts, bumps, or other persons using the facilities, rocks, forest growth, debris, branches, trees, roots, stumps, or other natural objects that are incidental to the provision or maintenance of a ski facility in NY State. NY Law imposes a duty on you to become apprised of, and understand, the risks inherent in the sport of skiing, which are set forth above, so that you may make an informed decision of whether to participate in skiing notwithstanding the risk. NY also imposes additional duties upon you to which you must adhere, for the purpose of avoiding injury caused by and of the risks inherent in skiing/snowboarding, including skiing/snowboarding under control. If you are not willing to assume all of these risks and abide by these duties, you must not participate in skiing/snowboarding at McCauley Mountain Ski Area.
